A Primer on Ancillary Rights

The term “ancillary rights” has historically referred to unwritten rights that were read into easements and right of way instruments to allow for the full exercise of the rights expressly granted. Over time, however, ancillary rights have come to be explicitly articulated, and in some cases, impose a considerable burden on the landowner outside of the designated easement or right of way area. The panel will discuss the origin and evolution of ancillary rights, Land Title Office procedures, and will explore appraisal considerations resulting from the inclusion of ancillary rights.

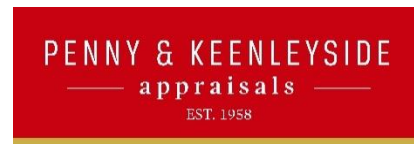
